LOCATION: Michael McNamara, MD, Kevin Paisley, DO, Jason Gray, MD, Robert Thomas, PA-C, and Jennifer Fayette, PA-C are located in Midtown, Anchorage in the MGM Professional Building at 4015 Lake Otis Parkway, Suite 201, Anchorage, AK 99508.

OFFICE HOURS: Our office hours are from 8:00 AM to 4:30 PM Monday-Thursday and 8:00 AM to 3:00 PM on Friday.

VISIT COST: A new patient visit can range in cost from \$175.00 to \$550.00. This charge does not include x-rays or injections (if necessary at the time of your visit) or any additional testing required outside of the office (such as nerve conduction studies). **Your deductible and co-insurance are due at your visit.**

X-RAYS: As hand, elbow, and shoulder specialists, we require x-rays for most appointments. Please bring any recent x-rays to your appointment. If new x-rays are necessary, our registered radiology technicians will assist you, using the latest in x-ray equipment.

INSURANCE BILLING: As a **courtesy**, we will bill your insurance company for your visit. Be aware it is your responsibility to know your co-pay and/or deductible information. We do require a deposit for surgery. This deposit is dependent on your insurance coverage and will be discussed at your pre-operative appointment. We do not accept auto accident insurance or homeowner's policy insurance.

APPOINTMENT RESCHEDULE OR CANCELLATIONS: Appointments with Dr. McNamara, Dr. Paisley, Dr. Gray, PA Thomas, and PA Fayette are normally scheduled in advance. If it is necessary to reschedule or cancel your appointment, please allow 48 hours notice. You may contact the receptionist at 907-771-3500, Option 2.
